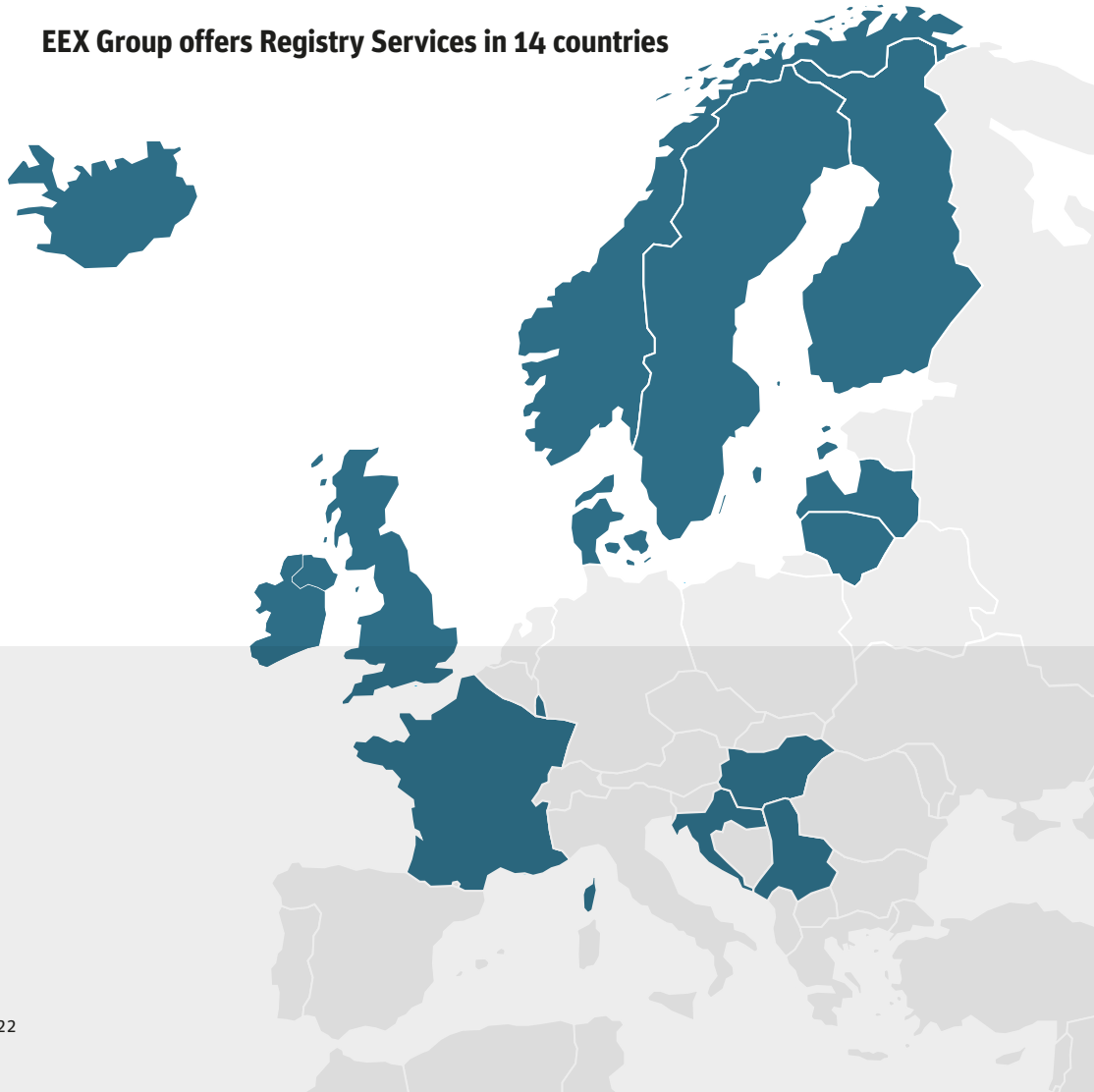

Dry Bulk Freight

EEX Group launched its Dry Bulk Freight business in 2016 to support and enable its customers to trade and clear a broader portfolio of products from a global perspective via both EEX and its Singaporean arm, EEX Asia.

In 2020, EEX Group saw unprecedented growth in its Dry Freight business, achieving double, triple and even quadruple digit increases in volume share (May 2020: 50.5 % / May 2019: 3.48 %), OI share (May 2020: 54 % / May 2019: 7.7 %) and number of counterparties actively trading (+132 %). - › ECC handles the financial settlement of contracts in various currencies (EUR as well as GBP, USD, JPY).
- › With a global network of more than 600 participants, clearing banks, TSOs and further partners, customers can rely on a liquid and secure network for trading energy and commodities.

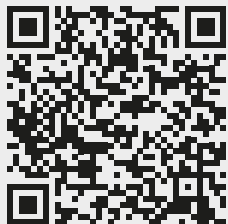
